

CONDITIONS OF USE OF LEMONERO.NL WEB SITE

1. PREAMBLE

- 1.1. The operator of the web site www.lemonero.nl (hereinafter just “**LEMONERO web Site**”) is Lemonero B.V., registered address: Westplein 12, 3016BM Rotterdam, registration number: RSIN 864285218, establishment number 000053320557 (hereinafter the “**Operator**”).
